Oregon Supplemental Statement to Accompany
U.S. Department of Labor Certified Payroll Form (WH-347)

⚠️ IMPORTANT: DUAL JURISDICTION REQUIREMENT

When a project is subject to BOTH Oregon prevailing wage laws (ORS 279C.800-870) AND federal Davis-Bacon Act requirements, the federal WH-347 form alone is **NOT SUFFICIENT** for Oregon compliance. This BOLI Addendum must be submitted with each WH-347.

✓ ANNOTATION: Oregon-Specific Requirements

- CCB License: Oregon Construction Contractors Board license required
- Public Works Bond: Required for all public works projects in Oregon
- BOLI Rate Book: Published January 1 and July 1 each year

SECTION 2: WAGE RATE COMPARISON

| Rate Type | Federal Davis-Bacon | Oregon BOLI | Rate Paid |
|-------------------|---------------------|-------------|----------------|
| Basic Hourly Rate | \$42.50 | \$40.85 | \$42.50 |
| Fringe Benefits | \$18.75 | \$17.25 | \$18.75 |
| Total Hourly Rate | \$61.25 | \$58.10 | \$61.25 |

💡 KEY PRINCIPLE: Pay the HIGHER Rate

When both federal and Oregon rates apply, you must pay the HIGHER of the two rates. In this example, the federal Davis-Bacon rate (\$61.25) is higher than Oregon BOLI (\$58.10), so the federal rate is paid.

SECTION 3: OREGON CERTIFIED STATEMENT

1. The contractor holds a valid Oregon CCB license and Public Works Bond.
2. All workers have been paid at least the applicable Oregon prevailing wage rate.
3. Worker classifications match BOLI classifications in the applicable rate book.
4. Where federal and Oregon rates differ, the higher rate has been paid.
5. All required records are being maintained as required by ORS 279C.845.
6. This addendum accurately supplements the attached WH-347 form.
